



Primary Dialogue: Multiple ESG Issues

**Summary:** 

#### Redefines's ESG strategy:

- Strategy is supported by targets with baselines, metrics and short-, medium- and long-term milestones and horizons.
- ESG strategy aims to deliver a meaningful impact on the primary and secondary UN SDGs (9 primary and 4 secondary SDG's that they align with)
- Reasonable and achievable short, medium and longterm goals that will allow Redefine to achieve the Net Zero goal by 2050.
- SETC monitors progress in achieving the the UN SDGs on an annual basis in the context of the agreed upon 2030 targets.
- Rem committee Has aligned ESG-related executive KPIs to the UN SDGs.
- Sustainable Finance: issued R4.2 billion use-ofproceeds green bonds since September 2022.
- Progress: Positive Progress

Primary Dialogue: Multiple ESG issues

Summary:

- **Environment:** Committed to the Science-based Targets Initiative. Conducted a climate-scenario analysis. Developed a group-wide decarbonisation plan.
- **Social:** Investment of more than US\$2 million on employees' career development, training, and accreditations. Launch of wellness webinar series. R8.9 million spent through the Datatec Foundation to support education in STEM. Investment of over US\$100 000 in community support initiatives.
- Progress: Positive progress

Summary:

#### Updates on the developed 2030 ESG targets:

- In 2022, achieved zero fatalities, 5 serious injuries, and zero serious environmental incidents in safety, health, wellbeing, and environment goals.
- For gender diversity, reached 23% women representation, 25% in leadership, and 55% in core roles.
- In decarbonization, achieved 18% absolute emission reduction and 1% net emission increase.
- In water stewardship, improved water recycling to 75%, with a 41% reduction in freshwater use.
- **Progress:** Positive progress


